

Sycamore Ridge Pool Rules

The rules and regulations listed below are for the protection and benefit of all. Your cooperation in abiding by these rules will afford safe and pleasant relations and recreation for all concerned.

- **ALL CHILDREN AGE 14 and UNDER MUST BE ACCOMPANIED BY AN ADULT.**
- **PARENTS ARE SOLELY RESPONSIBLE FOR THE ACTIONS OF THEIR CHILDREN AND ARE REQUESTED TO CAUTION THEIR CHILDREN TO OBSERVE AND OBEY ALL POOL RULES.**
- **ANY FAILURE TO COMPLY WITH THESE RULES MAY RESULT IN SUSPENSION OF POOL USE PRIVILEGES.**
- **RESIDENTS ARE ENCOURAGED TO REPORT ANY VIOLATION OF POOL RULES TO ANY MEMBER OF THE POOL, CLUBHOUSE, AND TENNIS COURT COMMITTEE. CONTACT NUMBERS ARE LISTED BELOW.**

ALL PERSONS USING THE POOL AREA ARE DOING SO AT THEIR OWN RISK.

1. All persons using the pool or pool area do so AT THEIR OWN RISK AND RESPONSIBILITY. **Sycamore Ridge Association of Owners, Inc.**, our current pool contractor, **Clarity Pool Management**, and **HOA Management** assume no responsibility for death, injury, or loss of personal property in connection with such use.
2. The pool is for Sycamore Ridge property owners and their guests only. Property Owners are limited to four (4) pool guests per household unless the clubhouse and recreation area has been reserved for that specified time. All guests must be accompanied at all times by the host resident. Property Owners are responsible for the behavior of their guests.
3. Pool hours are from 9:00 am to 10:00 pm - Monday through Sunday. Please use the shower/footbath provided prior to entering the pool
4. The pool closes at 10 pm and all property owners are asked to leave at that time. If a property owner has reserved the clubhouse and recreation area for that specified time, they must observe the private party policies and are responsible for controlling noise while at the pool area after 10 pm.
5. Property owners and their guests are required to wear some form of swimsuit while using the pool. Cut offs, dungarees, and other street clothes will not be permitted.
6. The pool furniture is owned and maintained by the association of owners for the sole benefit of all property owners. All pool furniture should remain inside the fenced pool area at all times. Pool furniture should never be allowed in the pool. The caustic nature of chlorine used in pools can damage the internal (non-treated) components which can significantly reduce the lifespan of the pool furniture.

7. Due to the limited amount of pool furniture please restrict usage to only what is absolutely necessary for your needs. All pool umbrellas are to be kept in the closed (cranked down) position unless in use. If you open an umbrella it is your responsibility to close it and return any pool furniture you moved back to its original position prior to leaving the pool area.
8. **THERE WILL BE NO LIFEGUARD ON DUTY AT THE POOL.**
 - **CHILDREN AGE 14 and UNDER AND NON-SWIMMERS MAY USE THE POOL ONLY IF ACCOMPANIED BY AN ADULT SUPERVISOR (parents or guardian). DO NOT ASK OTHER PROPERTY OWNERS TO WATCH YOUR CHILDREN AT THE POOL.**
 - **CHILDREN 15 AND OVER MAY USE THE POOL WITHOUT ADULT SUPERVISION ONLY IF SAID CHILDREN HAVE THE PERMISSION OF THEIR PARENTS.**
9. No smoking is allowed at the pool or pool area. Spitting, spouting water, blowing the nose or discharging bodily wastes in the pool is strictly prohibited. Running, boisterous or rough play, water balloons or excessive noise is forbidden in the pool area or bathrooms.
10. No means of transportation other than feet, crutches, and wheelchairs are allowed inside the fenced pool area.
11. All persons using the swimming pool must take a shower before entering the pool. Any person having an infection or communicable disease is prohibited from using a public pool. Persons having open blisters, cuts, etc., are not allowed to use the pool.
12. Coolers are allowed in the pool area, but **NO GLASS OF ANY TYPE WILL BE ALLOWED.** All trash must be picked up and put in trash containers on site or taken off the premises.
13. **PETS ARE NOT ALLOWED IN THE POOL AREA.**
14. **ANY DAMAGES TO THE COMMON AREAS OF SYCAMORE RIDGE OR THE PROPERTY OF OUR ASSOCIATION OF OWNERS WILL BE CHARGED TO THE RESPONSIBLE PARTY.**
15. **THE SAFETY EQUIPMENT IS THERE FOR A SPECIFIC REASON. IT IS NOT TO BE USED AS A TOY. DO NOT USE THE POOL UNLESS SAID SAFETY EQUIPMENT IS ON SITE AND READILY ACCESSIBLE.**
16. Please be considerate of neighbors when playing your radio by the pool.
17. No swimming is permitted during thunder and/or lightning storms.
18. **IN ADDITION TO THE ABOVE, ALL SWIMMERS MUST COMPLY WITH THE POOL RULES POSTED IN THE POOL AREA.**

19. Notify ANY Pool, Clubhouse, and Tennis Court committee member of any misuse of the pool area or damages to pool furniture. Take license plate numbers for any non-resident use, if possible. Contact numbers are listed below.

21. **If you are the last one to leave the pool area, always make sure to lock the bathrooms and all gates into and out of the pool area to insure that the pool area is secure.**
22. Non-potty trained children are allowed in the pool if and only if they are wearing approved swim diapers (call Upstate Pool Management (864) 688-1143 for a list of approved swim diapers). In case of a fecal accident or any other contamination of the pool, the parent shall IMMEDIATELY notify:
